Notes to proxy

- 1. If you are voting on behalf of a corporation or another individual you may be required to provide documentation evidencing your power to sign this proxy with signing capacity stated. If you are voting on behalf of a corporation you are required to provide your name and designation of office, e.g., ABC Inc. per John Smith, President.

- 4. If this proxy is not dated, it will be deemed to bear the date on which it is mailed by Management to the holder.
