

CONSTELLATION SOFTWARE INC. ANNOUNCES ANNUAL INTEREST RATE FOR SERIES 1 DEBENTURES

Toronto, Ontario – January 20, 2017 – Constellation Software Inc. (TSX: CSU, TSX: CSU.DB) (the "**Company**") announced today that the interest rate applicable to the unsecured subordinated floating rate debentures, Series 1 of the Company (the "**Debentures**") will be reset to 7.9% per annum on March 31, 2017. This new interest rate is equal to the annual average percentage change in the "All-items Consumer Price Index" published by Statistics Canada during the 12 month period ending on December 31, 2016 plus 6.5% and will be reflected in the June 30, 2017 interest payment on the Debentures.

The current interest rate of 7.6% will remain in place until March 30, 2017. The interest rate applicable to the Debentures will continue to be reset on an annual basis on March 31 of each year.
